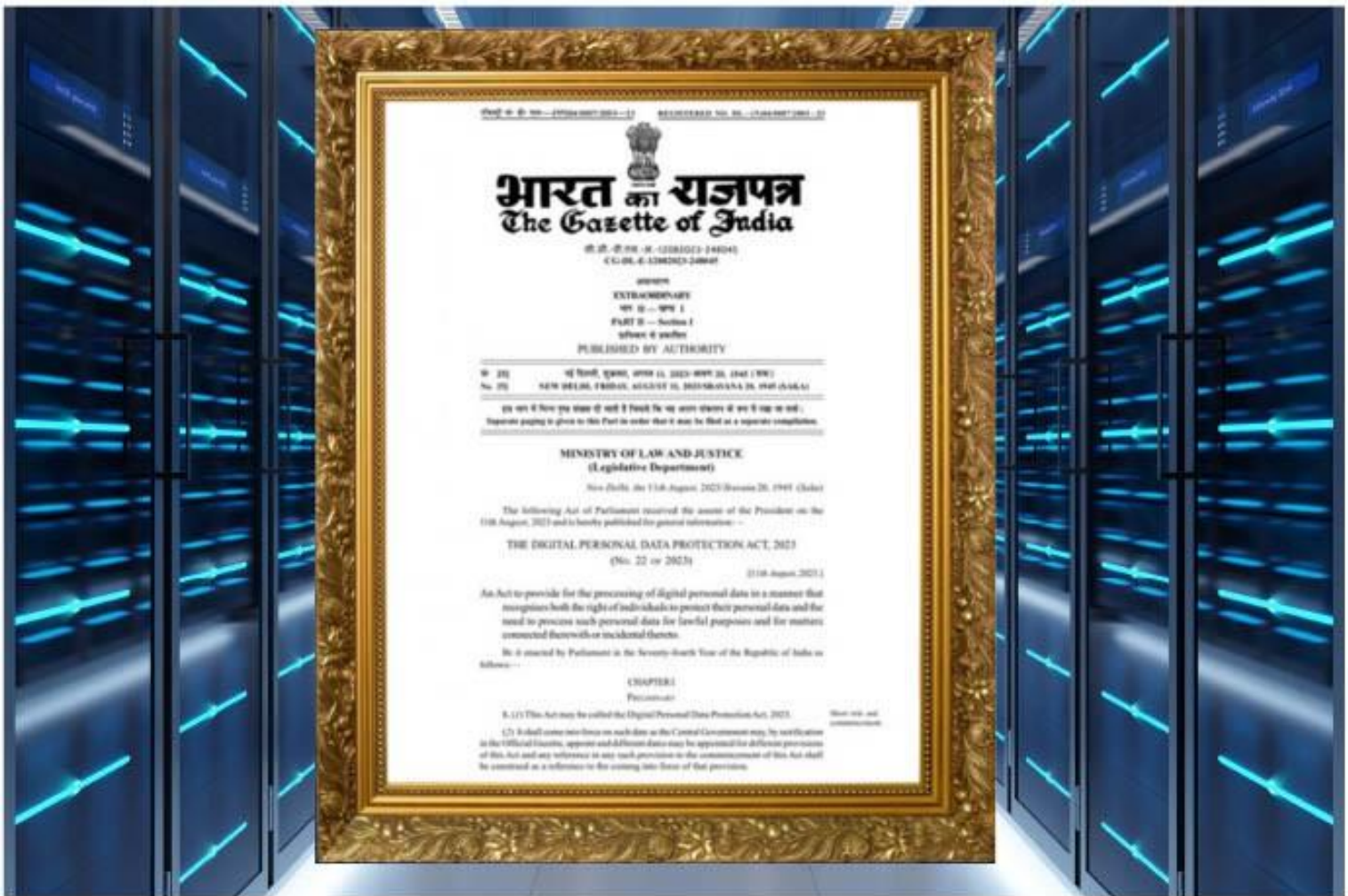

नई दिल्ली। भारत में डाटा साइंस की पढ़ाई का बाजार 2028 तक सालाना 57.5 फीसदी बढ़कर 1.39 अरब डॉलर (11,569 करोड़ रुपये) का होने अनुमान है। शिक्षा प्रौद्योगिकी मंच इन्फोब्लॉग्स लर्निंग व हैदराबाद स्थित प्रौद्योगिकी पोर्टल एनालिटिक्स इनसाइट के संयुक्त अध्ययन में यह जानकारी सामने आई है।

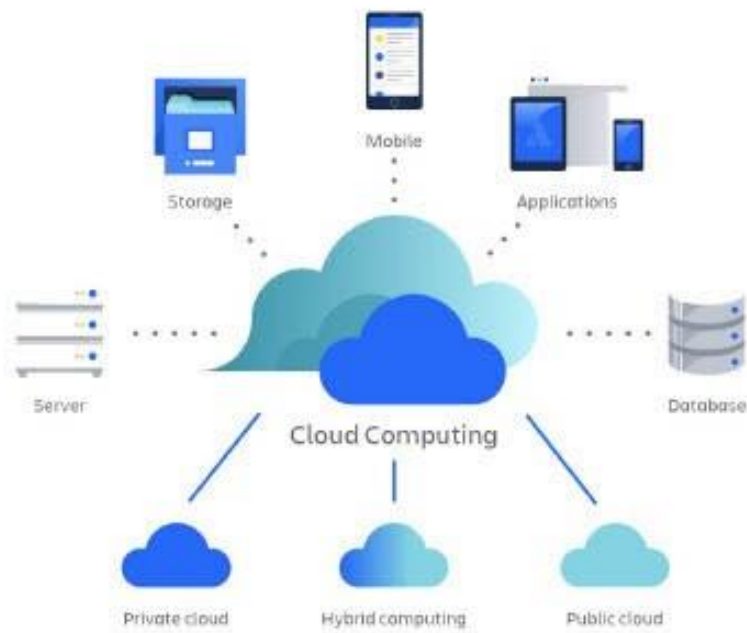

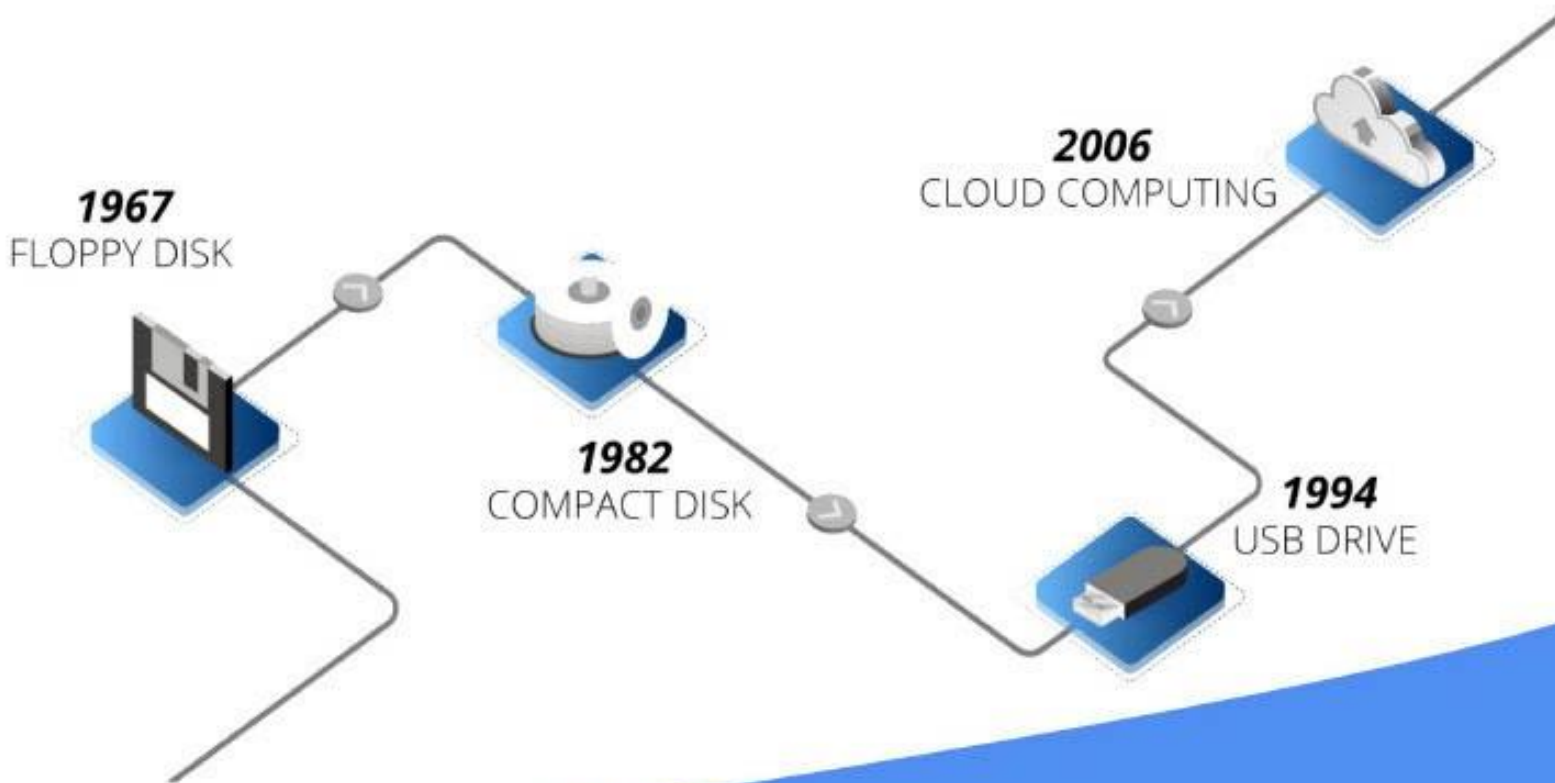

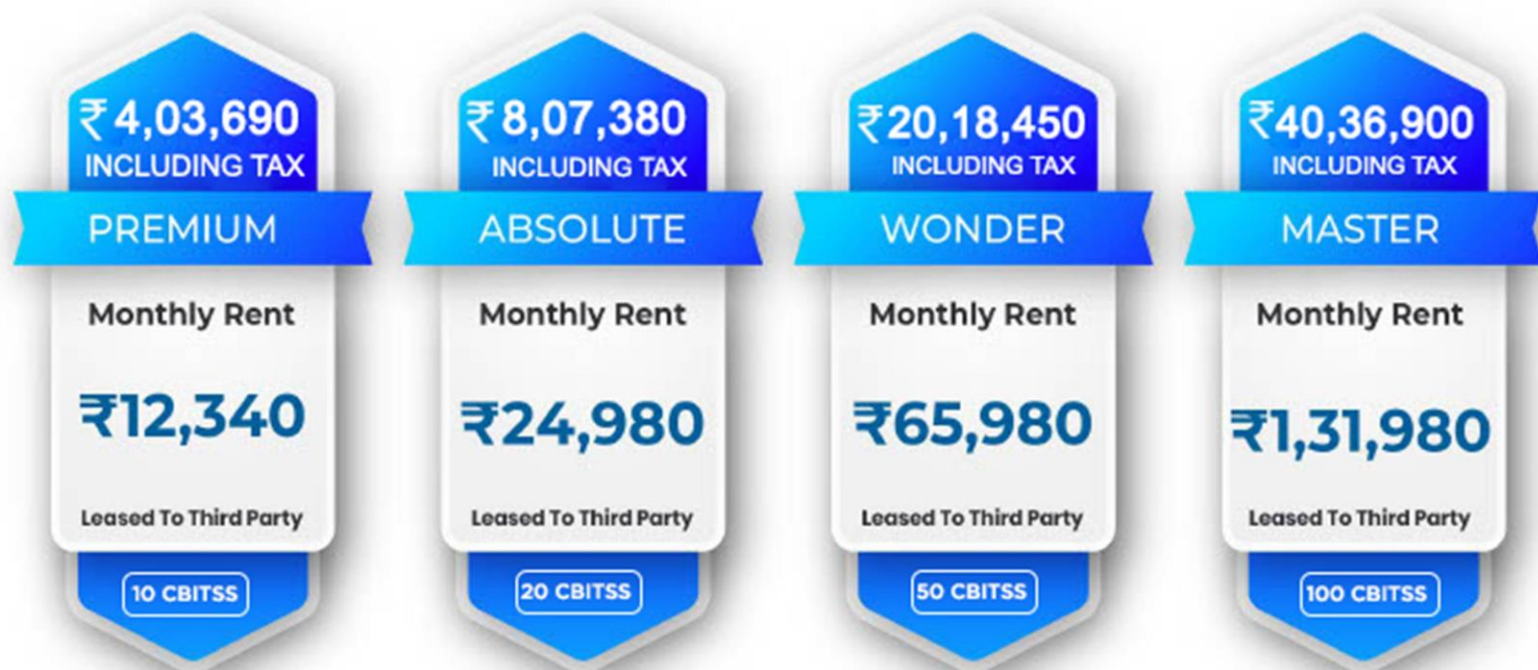
